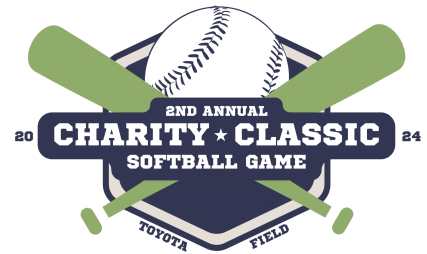


The Enrichment Center 2024 2nd Annual Charity Classic Softball Game

2. Game

- a. Will participate in 7-inning slow-pitch softball game
- b. The Enrichment Center will provide: bats, softballs, jerseys, hats, helmets
- c. Player will provide
 - i. Glove, Plastic Cleats or Turf Shoes, Remaining Uniform items

3. Time Commitment

- a. Player Information Meeting - Tuesday, January 9th @ 5:30pm
- b. 2 Team Practices - Dates TBD: March/April (minimum 2 hours)
- c. Event Day: 12:00pm - 7:00pm
 - i. Official game day schedule will be provided at the player meeting.
